## MEMORANDUM OF EDUCATIONAL COOPERATION

Between

UNIVERSITY OF ISFAHAN (I. R. IRAN)

And

FUNDACIÓN IMDEA ENERGÍA (SPAIN)

This Memorandum of EDUCATIONAL COOPERATION is entered into force as of March 7<sup>th</sup> 2018 by and between the:

- Fundación IMDEA Energía, Avenida Ramón de la Sagra 3, E-28935 Móstoles – Madrid, Spain, hereinafter referred to as IMDEA Energía, represented by its Director, Prof. David Serrano Granados.
- The University of Isfahan, Daneshgah Street, Isfahan, Iran represented by its president Prof. Hooshang Talebi.

collectively named in the context of this Memorandum as “the Parties”.

### PURPOSE

The purpose of this Agreement is to set forth the rights and the obligations of the Parties with respect to the scientific stays of researchers and students from the University of Isfahan due to take place at IMDEA Energía.

### THE PARTIES AGREE AS FOLLOWS

**Article 1.** The relationship student – IMDEA Energía does not mean further commitment than the stipulated in the present Educational Agreement, and no legal obligations related to a work contract will be derived from it.

**Article 2.** The specific training conditions will be agreed between the Parties and will be duly established in the ANNEX I.

**Article 3.** The attached **ANNEX I** will have to be signed by the student and by the tutors of the Parties. The **ANNEX I** encloses the student personal data; University where he/she performs his /her studies, the name of the tutor from IMDEA Energía and from the University of Isfahan, the duration of the training period at IMDEA Energía as well as a brief summary of the training objectives.

**Article 4.** During the stay at IMDEA Energía, the student is subject to the rules of the Institute, in particular, to those concerning working hours, health and security, as well as to follow the recommendations and guidelines given by the tutor at IMDEA Energía.

**Article 5.** No work contract, between IMDEA Energía and the student will be signed, unless the present cooperation agreement is cancelled or finished with regard to the affected student.

**Article 6.** IMDEA Energía will provide the student with the necessary research infrastructure.

**Article 7.** The candidates will be responsible for the travel costs, the accommodation and the allowance costs and will be responsible for acquiring a health insurance covering sickness and accidents.

**Article 8.** At the end of the stay, the student will present a report of their works during the training period. The report will require the approval of IMDEA Energía and the University of Isfahan.

**Article 9.** IMDEA Energía will issue a certificate acknowledging the student the period of the practical training, as well as the content of the training project.

**Article 10.** The present agreement becomes effective upon its mutual signing and will remain in force for period of 5 years. The signing Parties will reserve the right of cancelling this agreement at any time, if justified and sufficient reasons exist, notifying on writing the other part. It will be understood as a justified reason the non-compliance with the internal procedures existing at IMDEA Energía. The agreement may be amended or extended upon written agreement by both parties.

**Article 11.** All information and/or data that may be exchanged, acquired and shared in connection with the area of cooperation between the Parties and the students and the Parties pursuant to this agreement shall be treated strictly confidential and shall not under any circumstances be divulged by the receiving party to any third party without the prior

written consent of the originating party unless otherwise the same has already been in public domain.

**Article 12.** The student must maintain confidentiality with respect to all information communicated. This includes all information communicated orally, written (documents, articles, etc.), computerized information, designs, models, films, specifications, equipment or data in any form.

**Article 13.** Any work or result made by the researcher during the internship will belong to IMDEA Energía and Sending Institution. In the case of scientific publications, the researchers of IMDEA Energía who have participated and directed the work will appear as authors. In the case of inventions that could be legally protected by patent, the ownership will correspond to IMDEA Energía and Sending Institution and the researcher will be mentioned as inventor together with the other inventors of IMDEA Energía.
